**Neighborhood initiatives to sustain a strong sense of community, including the annual Jazz Fest and summer "camperships" for youth. The Jazz Fest was severely curtailed by COVID, but is getting back to somewhat normal contribution levels. We were able to send 22 youths to summer camp, for up to 10 weeks, during 2022. In 2021, we were able to send 20 youths to summer camp for twelve weeks. (10 youths for only six weeks in 2020, due to COVID.)**

**The Organization also coordinates a community garden that allows residents to grow their own vegetables, reducing the cost of their groceries.**

**Continued development of a database of residents and properties. Made presentations to local governmental units, continuing a community dialogue. Significant headway made toward initiating a comprehensive community revitalization project.**

**2022 also saw actual funding from Mecklenburg County to start implementing the revitalization plan. The FIRST HOUSE was purchased during 2022, and the long-awaited revitalization is moving ahead strongly for 2023.**
